16/181 APOLOGIES FOR ABSENCE

Received from Councillors John Oldfield (Chairman) and Steven Mountain (Vice-Chairman) (both personal business).

A minor typographical error having been corrected by hand, the Minutes of the Committee's meeting held on 13 December 2016 were agreed as a correct record of the proceedings and were signed by Councillor Francis.

16/184 THE DEPUTY CLERK'S REPORT ON ANY MATTERS OUTSTANDING FROM THE PREVIOUS MEETING, BUT NOT INCLUDED ON THIS AGENDA

The Deputy Clerk noted that Ronan Mellett of Nova Developments was due to call in at the Parish Office on 11 January 2017 in order to discuss amendments to the scheme proposed for Quiet Waters following the presentation at the 13 December 2016 meeting (Minute 16/168) and the possible involvement of the Community Land Trust in the scheme. The Committee would be updated in due course following that meeting.

The Deputy Clerk also noted that the Parish Office had learned earlier in the day that the Department for Communities and Local Government had announced the allocation of funds amounting to some £700,000 for community-led housing groups in the Arun District, of which the Angmering Community Land Trust was one such. The Clerk had made enquiries of the Director of Place at ADC, in order to obtain more information.

Councillor Thompson asked for a progress update concerning the Community Speedwatch scheme overseen by the Highways Sub-Committee.

The Deputy Clerk regretted that roadside training sessions for volunteers had not yet been carried out. The radar gun had been obtained on loan from Sussex Police and so it was simply a matter of arranging training sessions.
