17/177 DECLARATIONS OF PECUNIARY AND NON-PECUNIARY INTERESTS IN ITEMS ON THE AGENDA

The Chairman, Councillor Mountain, and Councillor Phelon all declared a non-pecuniary interest in application A/190/17/HH as they resided in nearby properties.

17/178 APPROVAL OF MINUTES

17/180 PUBLIC CONSULTATION

Mr Murphy drew the Committee's attention to his detailed letter of objection regarding application A/190/17/HH and wished to express concerns about the way in which the application, the previous application on the site, and the amendments to the application had been dealt with by Arun District Council. It was apparent that particular aspects of the proposed scheme had been altered in such a way as to attempt to game the system. The proposed extension also appeared to fall foul of Arun Local Plan saved policy DEV19.

The Chairman noted that the significant alterations to the original scheme had not been consulted on or indeed notified to the Parish Council.

The Deputy Clerk noted that ADC had apparently fallen into the rather unfortunate practice of allowing significant amendments to planning applications after they had been consulted on. This was clearly undesirable.

The meeting reconvened.

Decision: Objection. The Committee noted that its grounds for objection to the previous application remained. The proposed works were so substantial that they did not accord with Neighbourhood Plan Policy HD5 (Built Form) and nor did they accord with Arun District Council's saved Local Plan Policies DEV19 and GEN7.
