17/121 APPROVAL OF MINUTES

17/122 PUBLIC CONSULTATION

Roger Phelon, representative for Angmering In Bloom (AIB), presented the following report:
Future Projects

Following the Christmas and New Year holidays, AIB contacted Cooper Adams to find out if anything had been discussed with Ferring Nurseries regarding the area at the end of Station Road. Unfortunately, due to the holidays and a busy New Year period they have not had the opportunity to progress this further. It was explained to them that a plan for the area would be required in order for the PC to apply to WSCC for a licence. Cooper Adams will let AIB know when they have a proposal, AIB will then assist the PC Office with completing the necessary paperwork.

We have been making progress on the Village map project and have contacted a local art group who are interested in painting some of the buildings and illustrations for it. We have also arranged a meeting with Arun District Councils Art/Printing department to discuss producing the Village Map for us and the costs associated with it. We are planning to approach the Angmering Heritage Trust for a grant towards this.

We are investigating the possibility of putting up some additional floral baskets on some of the lampposts in the conservation area to complement the existing ones. The PC Office have asked us to identify where the new ones might be, so they can assess the impact on each particular lampposts prior to giving permission to do this.

Cllr Bicknell advised that there should have been artwork from previous signs.

17/124 BMX Maintenance / Event Day

BMX Track Maintenance has been carried out by Roy since February 2016. 2 tonnes of limestone dust has been purchased and used to maintain the track 16 times. During a recent visit the Installation Contractor commented on how good the track looks. Cllr Nikki Hamilton-Street said she had seen Burgess Hills track had grass, holes and water logging.

It was proposed that a BMX event be held biannually, and that the budget be increased to pay for the total resurfacing on top of the agreed maintain even budget. Cllr Paul Bicknell **PROPOSED** and it was **SECONDED** by Roger Phelon.
