REPORT FOR PC CLEW MEETING 28 MARCH 2018

Recent activities

We have started our Wednesday morning maintenance sessions in the Village Centre and at the Community Centre, but unfortunately have been rather unexpectedly snowed off on a couple of occasions!!!

We held a session with the Tuesday evening Brownies to provide, decorate and plant up a pot for Mother's Day. All sixteen girls were provided with a pot, a selection of items to decorate the pots and a primrose to plant in it. The girls really enjoyed it and Brown Owl was very appreciative of our involvement.

Future activities

We are still planning to plant the area behind and above the retaining wall at Water Lane with natural plants, similar to those already in situ.

We have offered to provide funds to plant up the Village Hall bed again this year as no other group has volunteered to do so. The Village Hall Committee's proposal was a display to celebrate the centenary of the RAF. We have asked Ferring Nurseries to plant and maintain this and the Village Hall will provide a plaque explaining its significance.

We are holding our AGM on Wednesday 21 March when after 4 years as Chairman I will not be seeking re-election but wish to let someone else with the time, commitment and enthusiasm take over.

Future Projects

We have had a few meetings with Ferring Nurseries discussing proposals by Cooper Adams for the area at the end of Station Road unfortunately these have not been thought to be feasible, so the discussion is ongoing. Once something has been agreed then a plan for the area would be required to enable the PC to apply to WSCC for a licence.

We have been in discussion with JUNA who have expressed an interest in planting up and maintaining the Beehive bed on the corner of Lansdowne Road, the licence for this bed is already in place.

We have been making more progress on the Village map project having enlisted the help of a local art group to produce paintings of some of the buildings and illustrations to go with our photographs. Arun District Councils Art/Printing department are willing to produce the design and we are getting quotes from local printing companies to print an A1 plastic backed colour version. We have been successful in gaining a grant from WSCC for a display lectern for the map which will be positioned, as agreed, on the Village green and are planning to apply to the Angmering Heritage Trust for a grant towards the other costs.

We are investigating the possibility of putting up some additional floral baskets on some of the lampposts in the conservation area to complement the existing ones. The PC Office have asked us to identify where the new ones might be, so they can assess the impact on each particular lamppost prior to giving permission to do this.

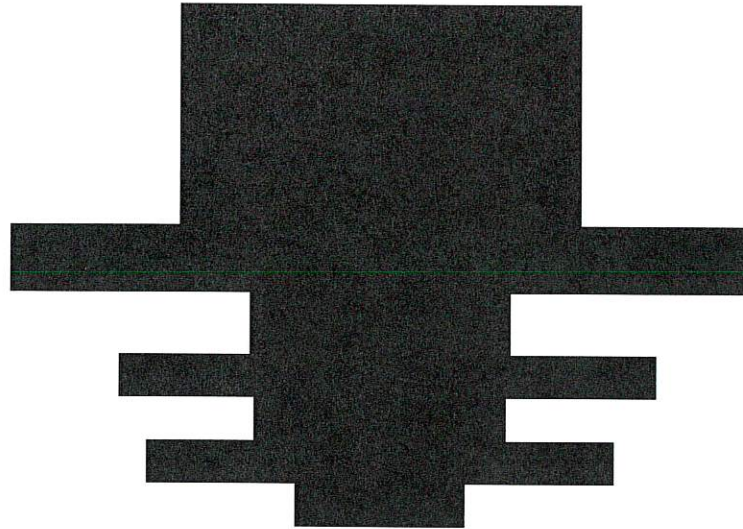
A Victim Impact Statement has been received with the request of the statement being in confidence and not to be stored or shared electronically but will be available for members of the committee on the evening of the meeting.

Due to reported anti-social behaviour and drugs paraphernalia being found at this location, the office recommend to the members of the committee for the gazebo to be removed to prevent youngsters congregating at this location, which also accommodates a toddler play area.

Four contractors were approached for quotations, with one quotation being received back.

Committee members are asked to consider the documentation provided, make a decision with regards to the removal of the gazebo and to agree the quotation received.

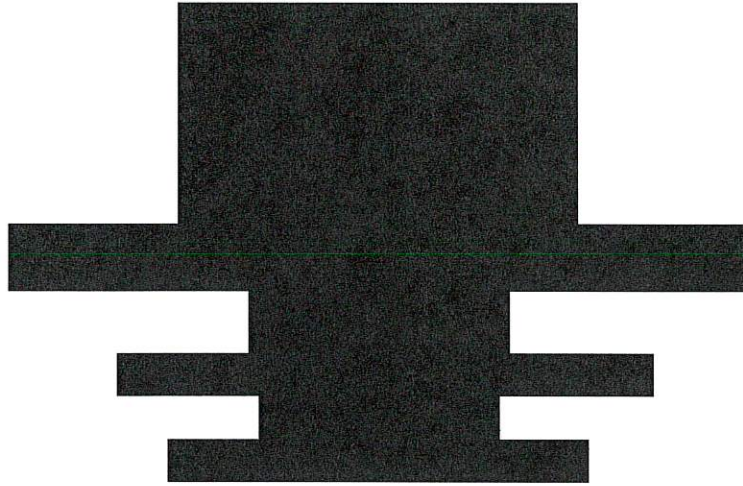
Agenda Item 10. Mayflower Park SUD Wall Repair.

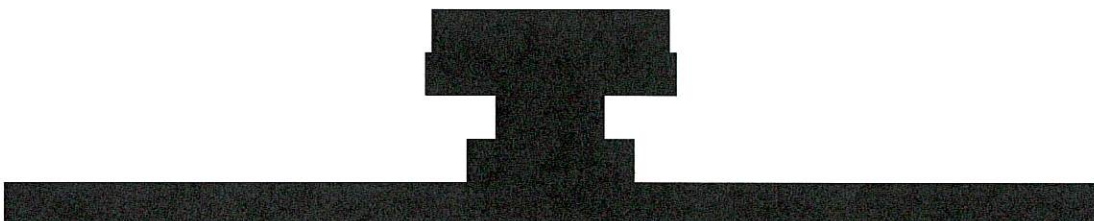
