### 18/040 PUBLIC CONSULTATION

Three members of the public gave their (opposing) views regarding planning application A/73/18/TC:

The view of the applicant was that for safety reasons they could not let the trees grow any taller. If they were allowed to grow taller, the applicant (St. Margaret's church) may not be able to afford to have the work done. The plan was to replace the trees with a hornbeam hedge.

The opposing view was that the trees were likely to be over one hundred years old, and ought to be inspected by an arborist, appointed by Arun District Council, with a view to potentially having a Tree Protection Order placed on them. The member of the public felt it would be outrageous to fell so many trees, particularly given that they were in a conservation area. It was felt that the arborist may recommend pruning, rather than felling, the trees. The argument was made that, as mature trees absorb water, removing them may add to the flood risk in the village. The trees also reduced noise and provided a barrier against the wind.
