Application for the removal of Condition 14 following grant of A/3/21/PL relating to the provision of a footpath along the site frontage with Roundstone Lane.

COMMENT: The development to the north of Pound Place has a footpath running south on top of the embankment on the eastern side of Roundstone Lane. It has an already constructed spur leading and ending at the perimeter fence of Pound Place and a new footpath should be constructed from this point to link up to the footpath to the south of Pound Place. It is essential that safe access is provided to the near by Bus Stop and safe pedestrian provision generally for residents of the development and all users of the road.
