#### 10 20/113 DAPPERS LANE WORKING GROUP

Cllr. Verrinder read out her report to the committee, detailed here:

The Group held their 2<sup>nd</sup> meeting on Tuesday 15<sup>th</sup> September 2020 by Zoom, where their reports of findings so far were discussed. Notes and reports of that meeting have been sent to HTP/Office. Also discussed was the walk along Dappers Lane on Saturday 5<sup>th</sup> September 2020.

Whilst on the walk, residents were curious as to what was going on, so time was spent in discussion with them. It occurred to the Group at the last meeting that it might be a good idea if the Groups purpose and objectives was publicised to the wider Angmering Community. I advised that this decision must be made by HTP and Parish Council: -

- a) Does HTP agree that this is a good way forward?
- b) If so, how should it be publicised?
- c) Not a good idea

Work on these reports will continue until recommendations can be made to HTP/Full Council.

Included in the report were three questions, **a-c** above — Cllr. Verrinder asked the committee for their comments. All present agreed that this was a good way to move forward and that it should be publicised on the APC Facebook page and in the APC website What's On section. Cllr. Cllr. Marsh commented that he had received an email form a member of the public asking about the possibility of revisiting the idea of average speed cameras in 4 different places with the aim to reduce speeding in the village.

Cllr. Oldfield stated that he and Cllr. N Hamilton-Street had contacted West Sussex County Cllr. Deborah Urquhart about this issue and are trying to arrange a meeting with WSCC Highways Engineers to discuss the general issues of traffic calming and the suggestions that have been put forward to understand what their current views are. Cllr. Oldfield will report back once the meeting has taken place; however this may not be for a while.
