ACTION FOR

The member of the public wished to bring 4 points to the committees

- He thanked APC for writing to ADC about the West of Dappers Lane development and he had seen that a stop notice had been put in place on the development.
- Regarding the heavy rain last week. He commented that dealing with flows in the Black Ditch was not the only flooding problem in Angmering. He said that a lot of water flows down Dappers Lane and many road gulleys were blocked. He also asked if there was any evidence last week that the road humps and cushions along Water Lane, through the Square and to Station Road from Dappers Lane to the village hall exacerbated surface water drainage problems.
- The member of the public then commented on the Broadlees application that was on the agenda as a later item. He said that it seems that positive drainage for the southern part of the site is proposed. The ditch on the north side of Water Lane purportedly drains to a pipe that crosses Water Lane to the Black Ditch. Regularly, somewhere downstream of the end of the ditch blocks, and water comes out of a road gulley near the south west corner of the site and runs down Water Lane. His concern was that if it happened again in the winter months it could be dangerous if it freezes.
- The final point was about local residents receiving a leaflet regarding a public exhibition about the large development north of Water Lane. He commented that he thought it was important that residents visit the exhibition to discuss matters with the design team and, if they have concerns, raise them formally with ADC when the Reserved Matters application was advertised.

A long discussion then took place with councillors giving their thoughts on the various points including flooding issues.

Cllr. Hamilton-Street gave her thoughts on what could be done i.e. cleaning leaves from drains and added that APC had requested a meeting with ADC, WSCC and local developers to discuss the various issues such as keeping roads clean during site development, but no response had been received as of yet.

Regarding the meeting being held on Wednesday 3 November re the large development North of Water Lane, APC will attend and they will be voicing all of their concerns which are highways, flooding layout and access.

Cllr. Hamilton-Street commented on social media posts as she was concerned that there was a lot of inaccuracy being shared regarding the development North of Water Lane. She said that she had put up a post explaining how the planning process worked. She also said APC had appointed the services of a Planning Consultant to make sure APC were correct in what they were saying. She finished by saying that APC would welcome comments from the public on their thoughts on what else could be done re the flooding issues in the village.



Cllr. Marsh thanked Barrett David Wilson Homes for their work in cleaning up the roads after the heavy rain. He also had concerns re the road ramp causing an issue with rain not being able to flow freely.

The member of the public left the meeting at 20:01.

Hamilton-Street told the committee that WSCC were not prepared and had no information to give. Cllr. Hamilton-Street commented that she had voiced her extreme disappointment and had asked that the meeting be postponed until they had the answers to APCs specific questions, along with those of East Preston and Kingston. Her final comment on this matter was that it was a wasted afternoon of everyone's time.

Cllr. Marsh wanted to voice his concerns over the traffic situation in the village centre i.e. all the road works that were taking place. He commented that he had been advised by local traders that this was having a negative impact on them.

Cllr. N Hamilton-Street commented that she felt WSCC Highways were aware of the disruption this was causing and also thanked the APC Office Team for their Facebook posts informing the residents of when these traffic controls were due to take place and any updates. A discussion then took place.
