**TAKE NOTICE** that the West Sussex County Council intends to apply to the Worthing Magistrates Court under Section 116 Highways Act 1980 for the stopping up of an area of highway measuring approximately 179 square metres located at 87a Downs Way, Angmering, West Sussex BN16 1AD on the ground that it is unnecessary.

The application is to be heard on **26<sup>th</sup> July 2019 at 2:00pm** in the Worthing Magistrates' Court at Christchurch Road, Worthing BN11 1JD

The effect of the Order sought will be to extinguish all highway rights over the land described above and for the purposes of identification only shown on the plan which may be inspected free of charge, together with a copy of the draft Order at the offices of West Sussex County Council, County Hall, West Street, Chichester, PO19 1RQ and Angmering Library, Arundel Road, Angmering BN16 4JS during normal library opening hours.

Any person to whom this Notice has been given or who uses the highway specified or who would be aggrieved by the making of the Order may appear before the Magistrates' Court to raise an objection or make a representation on the application.
