Precept and Budget Approved for 2021-2022

In the Autumn we undertook our first ever online survey to gain your views on aspects of the village that the Parish Council could do. We were amazed at the response, with ideas from young people about what would support the village. Some of the suggestions about helping to improve access to the South Downs National Park. What was as great to see was 73 people involved in activities to enhance our village – thank you!

In addition to this we held Councillor consultation sessions to gain their insight into aspirations for the village and community for the financial year and beyond. Everyone found these really positive, with some practical ideas, as well as aspirations that would be supported by a plan for external funding sources to make them come to fruition.

This has enabled us to create our business plan for 2021/22, a Parish Development Plan for 2022 and beyond, as well as a plan for access.

The Council were determined to deliver a balanced and effective budget and during a Full Parish Council meeting held on 15th November the budget was approved and Councillors voted unanimously to **not** increase the precept for 2021/22. This is the first time the precept has been held level for over 8 years, and as Councillors we hope that this helps recognise the challenges that many will be facing in unprecedented times whilst still allowing us to deliver the high standards expected of us.

Please note that whilst Angmering Parish Council have agreed to not raise its precept, your council tax bill may still go up due to other organisations such as Arun District Council, West Sussex County Council and the Police increasing theirs.**

It was unanimously agreed by councillors to not raise the precept for Angmering residents – for the first time in over 8 years.

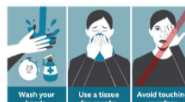

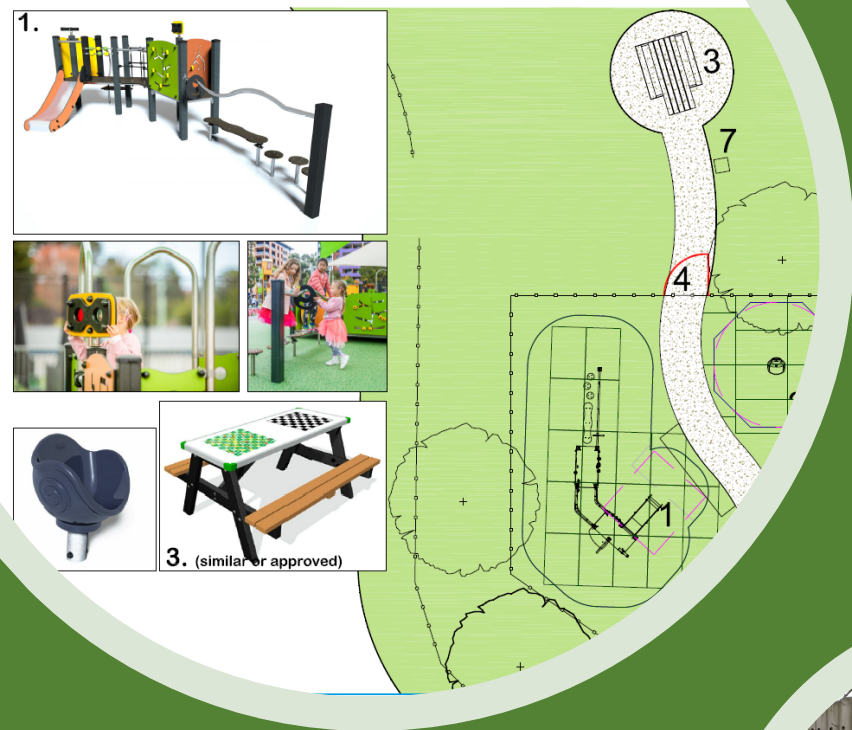
COVID-19 Response

COVID-19 Response - Over 219 people contacted the office to either ask for help or register a loved one.

Over 500 times help was given – which included shopping, food parcels, prescription collection, dog walking, registering for a friendly phone call, collection of library books and dropping of/collection of mail and parcels.

Councillors, staff and volunteers assisted with this effort, and continue to do so.

Blenheim Play Park

Completely refurbished including the planting of new trees in the area. The money earmarked for events in 2020/2021 was moved to cover the cost of the refurbishment so the current reserve for playparks was not affected.

Play Parks

Surveys were sent out to houses in the immediate vicinity of Braeburn and Pippin play areas to gauge such things as usage and suitability as well as asking for suggestions on improving the area and any other relevant comments.

This will feed in to the plan for these areas with the aim of improving the parks APC are responsible for.

The office have also been in contact with ADC for funding towards improving the park at Fletchers Field.

The multi-play unit in Discovery Play Park was vandalised and fully repaired.





Mayflower Park Pond

The walkway around the edge of the pond was damaged and needing attention. A total of 120 planks were replaced. This photo shows the work taking place.



Maintenance

Maintenance – Tree and hedge work along with grass cutting did not stop. Trees in Bramley Green and St Nicholas Gardens were pollarded and hedges were taken down to a manageable level.

Play parks all received their monthly inspections and their yearly external inspection took place as normal. Issues such as overgrown hedges on roads and highways continued to be reported to WSCC along with potholes.

Grass continued to be mowed by our contractor and groundsman. Tree and hedge work was also continued by our groundsman as well as litter picking, play park maintenance, safety checks of the Black Ditch and fly tipping hot spots.



Volunteers

Volunteer Litter Pickers – although delayed due to COVID-19 we persevered and now have over 40 litter pickers all furnished with litter pickers, sacks, gloves, hand sanitiser, sack hoops and hi-vis tabards. Funding was received from CALA Homes for a further 40 litter pickers and 20 hoops. Risk assessments, guidelines and COVID-19 advice given.

Community Allotment – A community allotment has been set up at Honey Lane. A shed was donated as well as lots of tools. Volunteers have signed up and been attending when restrictions allow. 2 sheds, tools, seeds and equipment have been donated. The plots have been cleared and planting has begun.

Grant Funding

Grants were successfully applied for from WSCC for Operation Watershed Funding to address the flooding of Cow Lane, and then allowing for \$106 money to be spent refurbishing the lane.

Grant funding was also applied for to supply hand sanitiser stations, a shop local map and also advertising in All About Angmering to help promote Angmering shops and businesses.

APC Grants – we also give out grants and in total gave out £6,5000. This included grants to The Angmering School for their small holding, 1st Angmering Scouts, St Barnabas Hospices, Angmering In Bloom, CAB, 4Sight, Angmering Cricket Club, The Poppy Club and Victim Support



Planning

Several extensive comments/letters were written on the South of Water Lane development and submitted to ADC with the help of local residents. All planning applications sent to the office for comment were taken to committee and comments agreed. APC councillors represented Angmering at Development Control Meetings held virtually by Arun District Council. Work continues with officers from ADC regarding compliance issues on several sites within Angmering.

Angmering Parish Council will continue to work hard for the residents and put forward their concerns regarding flooding, over development, Angmering heritage/conservation and infrastructure within the village.

APC meetings are open to all and we continue to encourage residents to attend.



West Sussex County Council and Arun District Council

Dappers Lane Working Group – A small group of councillors and residents of Dappers Lane formed a working group to discuss potential issues surrounding the lane and increased housing numbers. Several reports have been written and correspondence has been sent to WSCC. Discussions are taking place during HTP meetings and any updates given. This group continues to work extremely hard and want to make sure that lives are not negatively impacted by the increase in traffic to the area.



West Sussex County Council (WSCC) and Arun District Council (ADC) – We continued to liaise direct with both WSCC and ADC regarding safety issues on the Bramley Green cycle path, planning applications and compliance issues with development sites, use of CIL money, potholes, fly tipping, issues with Fletchers Field play park, road signs, overgrown bushes/trees and much more.

APC Office - We continue to advise residents to use the Love West Sussex app to report issues and have had many successes by reporting things this way.

The office produced an “Essential Local Contacts” leaflet as a result of lots of queries, this is available on our website and in hard copy from the office.

Christmas

Despite the restrictions we were still able to light up Angmering with a bigger tree, more lights and the addition of extra trees outside of many of the shops in the village and at Downs Way. The Memory Tree event was not able to be held but we distributed a tag to every house in Angmering so that residents could still put a memory of a loved one or a wish for 2021 on the tags and either hang it on their own tree at home or on the tree in the village.
