### 18/087 APOLOGIES FOR ABSENCE

Apologies were received from Rhys Evans (Vice-Chairman) and Roger Phelon.

# 18/088 DECLARATIONS OF PECUNIARY AND NON-PECUNIARY INTERESTS IN ITEMS ON THE AGENDA

Councillor Hill-Smith expressed a non-pecuniary interest in planning applications A/91/18/PL and A/111/18/DOC.

#### 18/089 APPROVAL OF MINUTES

The minutes of the Committee's meeting held on 7 August 2018 were agreed as a correct record of the proceedings and were signed by the Chairman.

# 18/090 THE CLERK'S REPORT ON ANY MATTERS OUTSTANDING FROM THE PREVIOUS MEETING, BUT NOT INCLUDED ON THIS AGENDA

The Clerk had no matters of note to report.

## 18/091 PUBLIC CONSULTATION

The Chairman mentioned that any comments made should be limited only to planning applications on the agenda. Planning application A/111/18/DOC (on the agenda for this meeting) was related to an anticipated application likely to be registered by the District Council in the immediate future. Both applications related to a proposed care home at Broadlees, Dappers Lane, about which the member of the public present, Mr Beckenham, wished to raise concerns.

Mr Beckenham said that he was very frustrated that his efforts over the previous three years to gain answers to his questions had proven fruitless. He said that all his letters to the District Council and to his local District Councillor had been ignored and he had not received any replies except for receipt of one letter from the Chief Executive of Arun District Council. The Chairman suggested that Mr Beckenham may wish to share this letter with committee members. The Chairman felt that while the other letters to the District Council should have been properly acknowledged, the District Council had yet to register the anticipated new planning application.



The Chairman said that the District Council should have referred Mr Beckenham either to the appropriate Planning Officer or to the Parish Council office; he should not have been referred to a specific councillor. This point would be made to Arun District Council.

Mr Beckenham said that the District Council had approved a number of other care homes, but he was concerned that the infrastructure was not in place to support them. The Chairman said that the committee could not comment further until it was in receipt of the planning application. He said it was likely that it would appear on the agenda for the next meeting of this committee, to be held on 18 September.

Mr Beckenham said he would produce a detailed position statement from residents once the application had been registered. He said he had met with district councillors and with the national press. The Chairman said that neither he nor the other committee members had been aware of this extensive background.

Mr Beckenham mentioned a public exhibition put on by the developer in the village hall in 2015, in which they had promised to engage with the public. He was disappointed to find that they had not. Mr Beckenham had written to the developer but had received no response. He felt that the developer and the consultant had a responsibility to the local community which they were not fulfilling. He had recently distributed three of his letters to members of this committee; raising five questions in his most recent letter. As these did not refer to A/111/18/DOC, Mr Beckenham would not raise the issues at this meeting, but would do so at the appropriate time.

The Chairman noted that the Parish Council had objected to the original application for the care home, mainly on the grounds of insufficient drainage provision (a point with which Mr Beckenham concurred). The starting point for the committee would be to look at that original objection. The committee would need to consider how the new application differed from the earlier application when it came before it for consideration. The Chairman would ensure that the Parish Council asked the District Council to give proper consideration to concerns about drainage and flooding.

The Chairman thanked Mr Beckenham for his input. If Mr Beckenham had any future papers for dissemination to this committee, he would take them to the parish office for scanning and distributing electronically to members. Councillor Marsh reassured Mr Beckenham that the committee tended to agree with the views of residents about this development and it was closely observing progress. Mr Beckenham thanked the committee for their time.
