18/001 APOLOGIES FOR ABSENCE

Apologies were received from Roger Phelon, Lee Hamilton-Street, and Norma Harris.

18/002 ELECTION OF NEW CHAIRMAN AND VICE-CHAIRMAN

This additional item was added to the agenda. Councillor Hill-Smith proposed Councillor Mountain for the position of Chairman and Councillor Evans for the position of Vice-Chairman. Councillor Marsh seconded the proposals, which were agreed by all members present. The newly proposed Chairman and Vice-Chairman accepted their positions.

18/003 DECLARATIONS OF PECUNIARY AND NON-PECUNIARY INTERESTS IN ITEMS ON THE AGENDA

Councillors Evans, Marsh, Oldfield and Mountain declared non-pecuniary interests in planning application A/219/17/PL.

18/004 APPROVAL OF MINUTES

The minutes of the Committee's meeting held on 23 April 2018 were agreed as a correct record of the proceedings and were signed by the Chairman.

18/005 THE CLERK'S REPORT ON ANY MATTERS OUTSTANDING FROM THE PREVIOUS MEETING, BUT NOT INCLUDED ON THIS AGENDA

The Clerk had no matters of note to report.

18/006 PUBLIC CONSULTATION

Planning application A/9/18/PL

Two members of the public, Messrs Castle and Castle, attended to hear the Committee's views on the above planning application. Councillor Marsh thanked them for their recent useful letter in support of this application, and noted that the site was not visible from the road. Mr T Castle confirmed that they owned the land, and invited Committee members to visit the site (at a pre-arranged convenient time) should they wish to do so.

Mr T Castle stated that the site was very small and there was no room for further expansion beyond the limited proposal outlined in the application. He said that the brothers

had spoken to Arun District Council in the past, with regard to appropriate traveller sites, but had made little progress so far.

The Committee advised Messrs Castle and Castle that it had no objection to their planning application and the Parish Council would enter a supportive comment when responding to it.

Approval of reserved matters following outline consent A/169/17/OUT for access. This application also lies within the parishes of Littlehampton & Rustington.

Land west of Brook Lane and South of A259, Angmering

**Decision:** Objection. As per reasons given for A/169/17/OUT: the site is not suitable for the type and size of development proposed in the application; there are particular concerns regarding highway access, the inevitable increase in traffic density and the imposition of additional load on the A259 roundabouts at The Body Shop and Golfers Lane. The Committee also has concerns over the additional burden this proposal would place on local healthcare services.

A/44/18/PL Land raising & use of land for car parking.

**Decision:** No objection

**Decision:** No objection

**Decision:** No objection. Angmering Parish Council supports this application.
