Cllr. Verrinder also added the following additional items:



Drainage - Arundel Road. The meeting at ADC went very well with all agreeing that the situation with this culverted surface water pipe must be dealt with. Paul Cann/APC will be contacting the company/person who conducted the survey prior to 2020 and requested that as the survey had to be abandoned, they now complete it – contact has been made by Paul Cann and awaiting a reply. Quotes are to be arranged to have the culverted pipe put back into a good working system. A further meeting will be held to discuss financing the project and setting a plan for construction/repair work and to deal with any legal matters, such as enforcement. A copy of the meeting report has been sent to all committee members.

It was confirmed that the proposed pipe from the attenuation pond will no longer run to the north of St Margarets School but to the south of the school alongside the foul water pipe.

It was also confirmed that the ditch system alongside the PROW to the west of the development and the recently constructed headwall and trash screen is to be revisited as there is concerns over the construction.

Leakage in Dappers Lane - It has now been confirmed by Southern Water that this leakage was due to a broken water pipe and that they are responsible for it. This was confirmed to Paul Cann by way of a letter which will be forwarded to APC. Southern Water have confirmed that this water leakage has now been repaired. Those using Dappers Lane are requested to report to APC any further problems.

AFAS - At our meeting with ADC, it was mentioned that Ray Drabble is no longer with WSCC. Confirmation is to be sought from WSCC as to how this will affect the proposed start date of September 2023. It has been confirmed by Cllr Urquhart that Phase 1 of the project is to go ahead and will start at the beginning of September until 6th October.

22 – Objection – The travel plan has not been rewritten after the Tucan Crossing was removed at appeal. Therefore the walking distance to Manor Retail Park for shops and access to the bus stop requires a 1.8km walk which involves walking along the A259.

**DECISION: Objection** 

COMMENT: APC concur with the comments from WS Highways. The walk to The Angmering School was omitted, it is 2.31km distance. The walk to the train station omitted, it is 2.89km. The PROW behind St Wilfred's School is often, in the winter months, a mud bath and unusable and would need upgrading. We believe the bus frequency stated is also incorrect. There is no recognition of the busy roads that will prohibit residents accessing SDNP easily.

#### A/177/23/NMA

Non-material amendment following grant of A/76/20/PL for the removal of 1.8m close boarded fence along the southern boundary.

**DECISION: Objection** 

COMMENT: Any agreement between the residents and the developer regarding the privacy and security of the residents of Garden Close and Woodland Close and replacement of the boundary fencing/hedging should be honoured by the developer and not at the expense of the resident.

It clearly states in the Town & Country Planning Act 1990 Section 96A (as amended) that "nonmaterial amendments are changes to a planning proposal that are very minor and do not materially alter the size and scale of the building, including its footprint and would not alter the descript of the development or the red edge area of the application". Therefore, APC feels that this application is NOT an NMA. Also we would like to draw your attention to the Officers Report for original app A/176/20/PL. It clearly refers to the southern boundary and layout and its impact on Garden Close. It goes on to talk about a 1.8m close board fence to provide high degree of privacy for Garden Close and that it is to be maintained by Persimmons. This MUST be adhered to.

# 7 23/088 PLANNING APPLICATIONS NOT ON A WEEKLY A/11/23/PL

Demolition of all buildings and structures and erection of retirement apartments with onsite car parking including 2 No spaces for Eachways and associated highways works including footway widening (resubmission following A/110/21/PL). This application affects the setting of listed buildings, affects the character and appearance of the Angmering Conservation Area and is in CIL Zone 2 (Zero Rated) as other development.

The APC comment has already been discussed via email and submitted to ADC. This decision was taken to ensure our comments were submitted to ADC in time for the Planning Committee Meeting due on 9 August 2023.

#### **ADDRESS**

**DECISION: No Objection** 

COMMENT: Angmering Parish Council has "no objection" to this development in principle. However, careful consideration is still required by the Planning Committee to ensure that our remaining serious concerns with regards to the potential of harm to the conservation area and increased flood risk are properly addressed.

The parish council concurs with the comments made by the ADC Conservation officer, and we are disappointed that windows, doors and rainwater goods are proposed to remain UPVC.

We have previously voiced our opinions and ADC have refused an application to change 25 windows from timber to UPVC in an existing property further along the High Street. UPVC is not acceptable as a

replacement for timber in existing properties, and flies in the face of all that heritage and conservation is trying to uphold. We strongly oppose the use of UPVC rather than timber for windows and doors in the proposed scheme. However, if UPVC is agreed it must be of the highest possible quality. This will not be secured without an appropriate condition requiring the approval of the local planning authority to be obtained (and for the applicant to be given clear advice at the time of consent as to what will be acceptable and what will not).

The parish council's view is that the use of flint on the two properties fronting the High Street would be more fitting for the conservation area but we note the views of the Conservation Officer in this regard. The proposed elevations show one dwelling as red brick and one white render — both of which are stark in their colour palette. We would ask that the render be beige or cream colour which would be more in keeping with the colours of other properties further along the High Street. This would also soften some of the brightness of the red brick dwelling — both colours appear to be fighting each other in the watercolour sketches.

We agree with the Drainage Engineer Report (14 June 2023) and urge the officers/committee to be sure that the flood risk to other property owners in the vicinity is not increased. The National Planning Policy Framework is clear that flood risk should not be increased elsewhere, including over the lifetime of the permission not just at the point of grant of permission. We note that a further response has been received from the Environment Agency and we hope that this will be available for the committee to consider when it makes its decision.
