Approval of the minutes of the meeting of the committee from Tuesday 6 December and email responses for Tuesday 20 December 2022 were agreed and were signed by the Chair.

4 22/177 THE CHAIRS REPORT ON ANY MATTERS OF INTEREST AND THOSE OUTSTANDING FROM THE PREVIOUS MEETING, BUT NOT INCLUDED ON THIS AGENDA. TO ALSO INCLUDE AN UPDATE ON THE STATUS OF THE ACTION LIST.

A copy of the Chairs report had been sent to all members and was accepted with no questions being asked. 6 items were added to the report and are listed below.

- 1. Application A/250/22/DOC Land at Dappers Lane (Heron Site) Condition 18 Surface Water Drainage. This application has been withdrawn at the request of the Developer.
- 2. Ref item 6) Just prior to the meeting McCarthy Stone sent APC a proposal, regarding a gift of a small piece of land on the corner of Cumberland and Water Lane to do with as they wish. this has now been replied to and we await their response.
- 3. The next round of Parish Workshops being run by the SDNP is on 15th March 2023 at 1800 at the Headquarters in Midhurst. Subject matters include Parish Priority Statements (as part of the Local Plan Review), Using Community Greenspace to benefit nature and people and Sharing information and best practice across the National Park. Would anyone else be interested in attending these workshops.
- 4. WSCC Highways have had a look at the signage at the top of Church Hill, opposite School House and it appears to be working.
- The Second Reading of The Draft Parliamentary Briefing / Levelling Up and Regeneration Bill is going through the House of Lords from today (17th January 2023)
- 6. There is currently nothing on the Action List

5. 22/176 UPGRADE TO SEWER NETWORK

Steve Anthony from Clancy attended the meeting but unfortunately the representative from Southern Water was not able to attend.

Mr. Anthony handed out a map of the area he wanted to talk about and explained what areas would be worked on and the type of work that would take place. He also said that they would be working closely with WSCC Highways. He explained that initially they wanted to start work at the war memorial end of Station Road but due to the works on the A259 they would now be starting where the Oval Racetrack used to be located. Road closures in short sections (residents and businesses would always have access to their properties), radar surveys, culvert issues and how long the project would take (approx. 5 – 6 months depending on what the surveys show) as well as issues relating directly to Dappers Lane were also covered. Questions were invited and discussions took place.

He said that he understood the amount of disruption these works will cause and would try to keep the disruption to a minimum. Road closure timings were mentioned, and a further discussion took place as members of the public had concerns that the times being proposed would not work for Angmering. This point will be taken away and looked at.

Cllr. Verrinder requested that regular updates were given so APC can share with Angmering residents, this was agreed. Mr. Anthony also stated that a letter was due to go out to 3000 residents prior to the start of the works plus advance work signs will be placed on the road side. Cllr. N Hamilton-Street had concerns regarding the school buses that use the village and



requested that My Anthony arranged that the schools in the village were contacted directly so they could be made aware of the works/closures.

One member of the public commented that he was pleased that he had attended the meeting and that Southern Water were being proactive. He then went on to ask questions relating to sewers, Mr. Anthony explained what was being planned along with the size of the sewers and who provided them.

Another member of the public asked what the road signs would say, it was reported that they would say 'Road closed ahead' and 'Road closed access to residents only'. Clancy were also looking at trailing other types of road signs which would give an approximate distance to the road closure point.

Cllr. Verrinder thanked Mr. Anthony for his time and he left the meeting along with one member of the public at 19:56.

6 22/177 PUBLIC CONSULTATION

One member of the public talked about the current road conditions, mainly pot holes, and felt that due to WSCC not maintaining the drainage system adequately has added to the road deterioration. Cllr. N Hamilton-Street commented that WSCC Cllr. Deborah Urquhart had attended the last Full Parish meeting and all these issues were raised with her. Cllr. Urquhart had reported that a new system for reporting problems like pot holes seemed to be working well. Cllr. N Hamilton-Street also commented that APC have been speaking with developers re the state of the roads. APC shares residents frustration with this situation and urged members of the public to come to the Full Parish meetings as councillors from ADC and WSCC will be in attendance and their concerns can be made directly to them. She also said to use the new website to report issues as soon as possible, the website is:

A discussion then took place with all members of the public regarding Dappers Lane being misused i.e. traffic going in the wrong direction and that it should not be accessible from the north. The use of signs was discussed as well as reporting issues to the Police. APC were working on getting a camera installed but the Police and WSCC Highways are saying this would not work. Cllr. Verrinder mentioned the working group that had been set up and their success in getting the bus re-routed.

After questions about the planning process were received Cllr. N Hamilton-Street explained how the process worked and that APC have been objecting to many of the developers applications. She also explained the issues behind not seeing any new schools of doctors surgeries. The lack of new doctors surgeries is down to the fact there not being enough doctors to run the surgeries and schools need to be at least 95% full and currently we are only 92% full in our area.

Cllr. Verrinder thanked everyone for their input and for attending the meeting and all members of the public left at 20:26.

COMMENT: The proposed variations around mortgages etc are too legalistic for responders to understand. From this APC understands that the developers are trying to delay the construction of the roundabout at the Water Lane/A280 Junction. The current \$106 agreement requires it to be completed before occupation of the 100th property – they are asking for this to be 200.

There are currently no details of this highway/roundabout proposal. At a previous meeting with ADC and the developers because of difficulties in Water Lane the roundabout may have to be moved further to the east. There has been no further information on this

APC feels that it would be totally unacceptable to approve this application as it could delay the implementation by a year or more and it would be wrong to expect the residents of Angmering to tolerate more years of dirt and disruption. The narrow village roads/lanes are already clogged with all the other developments Angmering has had to accept over the past 5-10 years

COMMENT: Although this was won on appeal APC still stands by its objections to the outline application. "Proposal results in an unacceptable loss of trees and a green space amenity to the detriment of residents and the street scene. It is presumed that this green area was a design feature in the layout of Downsway
