13 PI25/134 SOUTH DOWNS NATIONAL PARK

The chair gave the following updates:

Cllr Bennett and I attended the latest Parish & Town Council meeting on 1st October 2025 by zoom. An interesting meeting which highlighted and updated the events and matters that affect Parish & Towns within the National Park since the last meeting. There was a short discussion on the National Parks involvement in Devolution and Re-Organisation, sufficient to say that they are being asked for their opinions and guidance.

14 PI25/135 COMPLIANCE/ENFORCEMENT

Breaches of conditions set at application approval, and breaches of other matters requiring enforcement.

ENF/6/20 - Land at Merry England Nursery/Swallows Gate, Dappers Lane. More information on the progress of this Enforcement is awaited. It is possible that the upcoming appeal will relate to the construction of the footpath between the site and Merryfield Crescent, that part of Condition 10 still to be completed. The developer still has until April 2026 to comply with the Enforcement Notice.

15 PI25/136 APPEALS

Sought by an applicant as a result of an application refusal by the Local Planning Authority.

1) Swallow Gate Vehicle Access, Dappers Lane. - PINS ref: APP/C3810/C/25/3364403

We have been advised that from the 29th May 2025, the issue of an Enforcement Notice (ENF/6/20) is being appealed. we currently await further information on this appeal regarding the non-compliance with Condition 10 of A/142/16/OUT as varied by A/91/18/PL and detailed by A/111/23/DOC of 27th June 2023. Closure date for comments is 31st July 2025. Awaiting the date and location for the hearing.

2) Land West of Bewley Road. - PINS.ref: APP/C3810/W/25/3369419 Gleeson Land have now appealed against the refusal by ADC for the development of 190 residential dwellings and a community building together with the provision of open space, landscaping and associated infrastructure. Application A/154/24/OUT refers.

The date of the Inquiry is 28th October 2025 to be held in the Civic Centre, Littlehampton for a maximum of 8 days. The "Angmering Community Alliance" continues to meet and communicate with their legal team to discuss their strategy to put to the Planning Inspector. The result of the Inquiry may not be known until January 2026.

Highways Action List

A copy of the updated list was sent to all Councillors and the Chair went through the updates and said that the Clerk will continue to chase for further updates.

2) Traffic Regulation Orders

To receive an update on the issue of TRO's

- a) TRO for the A280 Speed Limit There has been complaints by residents that abut the A280 of the noise level generated by speeding traffic. WSCC Highways is aware of the speeding problem along with the road being used for time trialling. They are also aware of the number of accidents currently recorded, so, are investigating the matter with a view to implementing a TRO to change the speed limit to 50mph. This speed will align with that of the A259. This matter will be discussed at the Full Council Meeting in November 2025.
- 3) Other Highways Matters affecting Angmering Matters not included at items 1 and 2 that are time limited.
- a) Update on Water Lane Sewer work

Work is continuing although this may not now be completed until the new year.

- b) Update on Traffic Lights replacement on the A259 Work is continuing and will hopefully be completed next month.
- c) Traffic in Dappers Lane At the Full Council Meeting a resident highlighted problems still being experienced within the Lane. This was discussed together with the County Councillor and District Councillor. These problems relate to the misplacing of a 20mph sign and continual speeding along the lane. A request was made to look into our SID being placed in the lane the Clerk explained the reasons why it hadn't happened let 20mph bed in (at least 12 months). The Clerk will speak to WSCC to ensure that the sign is repositioned.

Conditions consistent with the Operating Schedule

General Objectives:

The activity will be limited to very small groups (maximum 6) of customers for limited time periods (maximum 4 hours at a time) for a maximum of 4 sessions per week. People attending the courses will be learning to make food during workshops and given the option to purchase alcohol during this time. The premises will only be serving alcohol for short and irregular periods in the afternoons up to 9pm. The activities therefore present an extremely low risk of impact to the 4 licensing objectives.

Prevention of Crime and Disorder:

Alcohol to be offered to serve to very small numbers of adults whilst attending a food making course only. Alcohol to be consumed on site can only be consumed in the alcohol consumption area on the premises. Alcohol to be consumed off site will only be sold in sealed containers (bottles of wine). No visitors allowed during food courses. No music or entertainment screenings.

Public Safety:

Alcohol to be offered to serve to very small numbers of adults whilst attending a food making course only. There are no public safety implications from this proposal with such a small number of customers consuming alcohol during the courses and the workshops being run not being open to visitors or members of the public.

Prevention of Public Nuisance:

Alcohol to be served during closed workshops delivered to people who have booked the courses only; i.e. closed to the public. All alcohol to be consumed indoors within a designated alcohol consumption area. No visitors allowed during food courses. No music or entertainment screenings.

Protection of Children from Harm:

No children will be allowed onto the premises whilst alcohol is being served..

Enquiry 3285669 - work needed will be completed once funds have been allocated. Bramley Way - As per the above. Roundstone Lane - As per above (part of same equiry) stating repeaters needed for 20mph signs. Update - Lack of 20mph signage - Roundstone Lane - 3285669: I have done some further digging into this section of road and I missed on site that this forms part of the 20mph Zone! The Department of Transport Traffic Signs Manual Chapter 3 (Section 8.7.1) specifies within a 'zone', speed limit repeater signage isn't required, so long as there is a sufficient traffic calming feature at regular 100m intervals. There are many types of traffic calming features that can be used within a zone, including speed humps, road marking roundels, pedestrian refuge, junctions or bends in the road. Update - HGV signage request - Arundel Road: I have looked into this again and discussed this with my Assistant Area Highways Manager. Ultimately, our stance remains the same as my previous email from Enquiry 3239955 in that there would be no suitable location for a sign at this junction within the Highway Boundary. Any signage advising vehicles that the road is unsuitable for HGVs could inadvertently cause a safety issue by alerting drivers too late as they approach the junction. This junction is sharp and manoeuvres could prove difficult, and telling vehicles in advance of the turning would be the most practicable solution. With this said, our stance regarding Unsuitable for HGV signs is that these are not currently a high priority. WSCC has adopted an evidenced based approach for these signs, and with the caveat that access is required to Arundel Road (a C-classification road with genuine business access), there may be no alternative route that is suitable for HGVs to use to enter Angmering. A280 - now the roundabout is being constructed - a sign may possible be added to say "Angmering Village Only" and "Not suitable for HGV's". Need to wait for final sign off of roundabout first.
