

Planning & Infrastructure Committee Chairs Report 19th September 2023

1) The following information has been received regarding the continuing work and closure of Water Lane.

Upgrading the sewer network in Angmering

We're constructing a new pipeline in connection with the new local housing development. To do this we need to do some overnight surveys along Water Lane.

We'll start work near the junction of Weavers Hill on 18 September 2023 moving towards the junction of Arundel Road for a period of about 2 weeks. The survey work is in manholes and underground.

Road closure

- We'll need to close Water Lane overnight between the junction of Weavers Hill and the pedestrian crossing at the junction of Arundel Road.
- On **18 September** we'll have to close Weavers Hill junction with Water Lane for a period of 2 nights between 8pm and 6am. You'll still be able to access Cumberland Road.
- Monday 18 September 2023, during the day, no parking cones will be put in place along the road between Weavers Hill and Cumberland Road. These will be put near the manholes we will be working on in that section of road. They will be in place for 2 days.
- Monday 25 September 2023 Weavers Hill junction with Water Lane will be closed overnight 8pm to 6am for 2 nights.
- Monday 25 September 2023, during the day, no parking cones will be put in place along the road between Weavers Hill and Cumberland Road. These will be put near the manholes we will be working on in that section of road. They will be in place for 2 days.
- A diversion route will be in place. You'll find a copy of the diversion route at the bottom of the letter.
- Depending where on the road we are working there may be times when you are not able to park directly outside your property. No parking cones will be used to indicate the area we will be working in as we move along the road.
- You'll always be able to access your properties, but you may need to follow the diversion route depending where on the road we are working.
- Late night businesses will be accessible.
- The surveys will be done overnight from 8pm to 6am to minimise impact to the Village. The road will be open as usual outside of these hours.
- The survey work is in manholes and underground. You may see vehicles moving from manhole to manhole. There will be fencing and beacons around the manhole we are working in.
- There will be minimal noise from our works.
- 2) On Wednesday 6th September 2023 I read out a dissertation at the ADC Planning Committee meeting in regards to application A/29/23, in which Roffey the developer of the Manor Nursery development applied to have the affordable homes portion of the agreement removed. It was made clear to the planning committee that the latest dictate from the Government is now giving developers wiggle room out of this agreement. Whilst it is understandable that small developers are experiencing financial difficulties due to Covid and the increase in materials, it must be understood, and was highlighted by ADC, that this may give the major developers the green light to also go down that road. Therefore, in agreeing to approve this application ADC will add a condition that the matter will be reviewed as development progresses. Once again those in need of affordable housing could lose out.
- 3) A working group meeting is being held with County to discuss the drainage problem on Heron's Park on 29th September. The application regarding the fencing on the boundary of Heron's Park and the dwellings on Garden Close and Woodlands Close has been withdrawn.
- 4) On Wednesday 4th October 2023, I am attending an online SDNP Parish Workshop to meet the new parish nominated members, the new National Park Chair Vanessa Rowlands and to be updated on Landscape and Planning matters within the National Park and how it could affect Angmering. The Chair also added the following additional items:

AFAS – WSCC has notified APC that there is a problem with the start date of the AFAS Phase 1 which was due to begin in September this year. The project has now been put back to the Spring 2024.

5 23/105 PUBLIC CONSULTATION

The member of the public requested a copy of the list mentioned in the minutes from the 18th July regarding agenda item 23/066 – the Clerk will provide a copy.

Clearance of the gullies at Dappers Lane was mentioned by the member of the public and it was advised that WSCC Cllr. Deborah Urquhart said this work would be completed by the end of July, but it was reported that work had not yet started.

The member of the public also commented on the fencing issues at Heron's Park and voiced their concerns. The Chair advised that a decision was still outstanding.

The member of the public will be sending the Clerk an email outlining their concerns regarding various matters.

The Chair said that a direction sign to the "Harvest Rise" development site in Arundel Road has been placed on a lamp post next to the village sign in the square. This has suggested to her that Redrow may be starting development soon and may be bringing all traffic to the site via Water Lane, The Square and Arundel Road, contrary to the approved Construction Management Plan which clearly states that construction traffic must access and exit the site via the A27. Cllr Hobson said that this sign may be for marketing purposes.

<u>Action</u>: The Parish Clerk will contact Redrow to have the situation clarified as "No Construction Traffic" is permitted on roads other than agreed.

Cllr. Want said that construction traffic to St Margarets School is using Arundel Road from the South and not from the A27, this must be clarified as construction vehicles have been seen in the village square.

Cllr. Hall mentioned a mirror to help residents see traffic coming had been taken away by WSCC and wanted to know if it could be replaced. Cllr. Oldfield commented that there was a problem with mirrors and that they were not being used anymore so it was very unlikely that this would be replaced.

- 1) A works instruction has been raised for the "Pedestrians in Road" ahead signs to be erected as discussed, and these works are due to take place at any time within the next 6-weeks.
- 2) A works instruction has also been raised for the 20mph roundel and SLOW road markings in Arundel Road these works are due at any time within the next 14-weeks.
