The Chair then reported on these Additional items:

- 1) Rule 6 of the Town & Country Planning Act

With regard to application A/154/24/OUT as a result of the refusal by ADC there is the possibility of an appeal being put forward by Gleesons, however, should this happen, we must be prepared. We have been advised that a similar case is going through the process of a [*Rule 6 for interested parties involved in an inquiry – planning appeals and called-in applications*](#) (Government Guidance) under the Town & Country Planning Act. This is something we should consider if/when the time arises. To view this document, contact the Clerk.

2) Action on Buses

You may have seen in a Newsletter from our MP Dr Beccy Cooper an article regarding the cuts to local services especially those to the Worthing Hospital. She says that the Government is investing £1Billion to support, improve and protect bus services especially the “Bus Services Bill”. This means that Local Authorities will have the power to set routes, fares and frequencies. Bus operators will not have the ability to decide on routes themselves. She said she would continue the campaign for her constituency and calling on WSCC to take up the new powers available in the Bill. The Bill started in the House of Lords and is now at the Committee Stage in the House of Commons.

There is to be another meeting for APC with the MP later in the year. Should Angmering be pressing now for a better more frequent service(s) for our ever-increasing community.

3) NALC – Joint Publication

In the latest NALC Chief Executive Bulletin dated 26 June 2025 the CEO states that he has been in discussion with CPRE regarding a Joint Publication “How to respond to Planning Applications”, now published. They are also discussing the updating of the publications “Neighbourhood Planning” and “Planning Explained”. All of these are useful publications that may help APC P&I with the applications they have to comment on. Contact the Clerk for copies of these documents.

4) Deferred Application A/39/23/PL

This refers to the construction of an Employment Park in Brook Lane, south of the A259 which was deferred at the ADC Planning meeting on 26th March 2025. It was deferred as a result of the change of flooding zone by the Environment Agency which needed to be investigated further. It will now be heard at ADC on the 9th July 2025. P&I offered no objection to this initial application as it would bring much needed employment and businesses to the Parish, however, it did raise concerns about the highways, footpaths and cycle-way links to the site, the rail link access and the nature/wildlife of the site and suggested a SuD be considered.

5) Western Sussex Rivers Trust Event

You will all have received an e-mail from the Clerk with two dates and times to be considered for a meeting in September to look at the problems facing our water environments and how they impact our communities and environment. As Flooding etc is part of P&I ToRs and experience, I would ask members to consider attending a meeting to find out what we can do to improve our own situation. Please notify your preferred date and time. I have stated 23rd September at 10:30-13:30 but am okay with the date & timings.

Action List – the remaining item on this list referred to the conservation area extension (see agenda item 12). It was agreed that this item is now deferred until 2027 due to matters outside of APC control.

Partnership Management Plan (PMP)

The Chair also reported that the consultation relating to the **Partnership Management Plan** (PMP) is now live until Friday 1 August 2025.

At Full Council on Monday 9 June, Cllr Evans offered to work with Cllr Verrinder to complete this consultation on behalf of APC. P&I Committee members are requested to have a look at this document and make any comments to the Chair, Cllr Evans and the Clerk.

The Chair and Cllr Evans reviewed this consultation on Tuesday 24 June. As there has been no comments from the rest of the committee it was submitted on Wednesday 25 June.

The content of the submission was discussed and Cllr Evans relayed some of the suggestions made, no questions were asked. Should any members of the committee like a copy of our comments then please contact The Clerk.

14 PI25/040 COMPLIANCE

ENF/267/23 - 8 Meadowsides – Fencing. Part compliance.

The Chair has noticed that the remaining panels have now been removed.

ACTION: The Clerk has been asked to seek confirmation from the Enforcement Officer that this item is now complied with and therefore closed, this has now been actioned.

ENF/6/20 – Land at Merry England Nursery/Swallows Gate, Dappers Lane – Tuesday 11 March 2025 Failure to comply with condition 10 of A/142/16/OUT as varied by A/91/18/PL and detailed by A/111/23/DOC of Tuesday 27 June 2023.

The item relating to the footway has now been approved by ADC, but the vehicle access is still ongoing. The Clerk has sought information from the Enforcement Officer regarding the current situation, who states that the Enforcement Notice has been appealed (ref. 3364403) and that any comments can be submitted by Thursday 10 July 2023. He also said that the appeal will run its course and then they will take it from there. We now await the hearing and result.

15 PI25/041 APPEALS

Broadlees 20 dwellings Dappers Lane - PINS Ref APP/C3810/W/24/3358077

Application **A/133/24/RES** was Refused by ADC on Monday 3 February 2025. Approval of reserved matters (appearance, landscape, layout, and scale) following outline consent A/153/22/OUT. This application is in CIL Zone 2 and is CIL Liable as new dwellings.

Councillors will now be aware that this appeal was heard on the Friday 6 June 2025 and dismissed by the Planning Inspectorate. Unfortunately, the appeal regarding costs did not go in favour of ADC due to, as the Inspector said, “unreasonable behaviour by the Council (ADC)”.

This was discussed with the Ward District Councillors at Full Council on Monday 9 June who were requested to take the matter back to ADC expressing the dissatisfaction and fear shown by APC. It was agreed that the Clerk and Chair of Council would write to the CEO Dawn Hudd.

A letter was sent to the CEO who replied and is looking into the matter as she does not agree with the decision, and needs the reasoning explained in more detail as to what the “unreasonable behaviour” was that the Parish & District now have to pay for.

Government Guidance on Appeals states that unreasonable behaviour in the context of an application for an award of costs may be either:

***procedural** – relating to the process; or*

***substantive** – relating to the issues arising from the merits of the appeal.*

The Inspector has discretion when deciding an award, enabling extenuating circumstances to be taken into account.

P&I has asked the Clerk to follow this through with the CEO and awaits the outcome.

Swallow Gate Vehicle Access, Dappers Lane. PINS ref: APP/C3810/C/25/3364403

We have been advised that from the Thursday 29 May 2025, the issue of an Enforcement Notice (as above) is being appealed. We currently await further information on this appeal regarding the non-compliance with Condition 10 of A/142/16/OUT as varied by A/91/18/PL and detailed by A/111/23/DOC of Tuesday 27 June 2023. Closure date for comments is Thursday 31 July 2025. A date and venue for the hearing is yet to be decided.

16 PI25/042 CORRESPONDENCE

- 1) Correspondence dated Tuesday 3 June 2025 has been received from McCarthy Stone notifying APC of the upcoming S278 highways works on Water Lane from Monday 9 June until Thursday 28 August 2025. This will of course go along side with the Southern Water sewage works also on Water Lane. The office is monitoring the situation with updates from both companies in order that disruption to the travelling public can be kept to the minimum. Any problems noticed are to be taken to the Clerk.
- 2) Correspondence was received from Mr Geoff Gibbs regarding application A/154/24/OUT expressing his views on this application.
- 3) Correspondence was received from the Planning Officer for application A/66/25/DOC – Wilmington, Arundel Road that the concerns addressed by APC after the approval by ADC of the Construction Management Plans routing of contractor's vehicles. The Planning Officer has spoken to the developer regarding the concerns, and it has been agreed by the developer that all vehicles to and from the site **must** use the A27 and not through the village centre via Arundel Road. Signage will be installed at the site exit to remind all site traffic to exit left for the A27.

- 4) We have received an e-mail from a Horsham District Councillor asking us to complete an e-petition <http://westsussex.moderngov.co.uk/mgEPetitionDisplay.aspx?> to help reduce the traffic speed in the villages along the A283 of Storrington, Sullington, Cootham and Cowfold. As our Parish borders Storrington and Sullington it could be affected by any pollution generated, the Chair felt APC should help our neighbouring councils, as we would hope they would help us, in their attempts to make changes by completing this e-petition which closes on the Sunday 6 July. The Chair suggested individual replies.

17 PI25/043 HIGHWAYS MATTERS

The Highways Action List (a copy was sent out with the Supporting Papers) was talked through with the Chair drawing the committees attention to the following actions:

- a) **TRO ARN2401** - Station Road Highways Lining – Information together with a photograph has been received showing that this TRO is now complete and can be removed from the list of outstanding highways matters.
- b) **TRO ARN2304** - Dappers Lane Road Signs and Speed reduction. Relating to this the Save Dappers Lane Group produced their survey which closed on Monday 30 June. We now await the outcome before the group goes through the process of a Community Highways Scheme with WSCC.
- c) **TRO ARN2404MM** consultation relating to parking outside the shops went live on Thursday 19 June and closed today Thursday 10 July 2025. We now await the result of the consultation.

Need for more 20mph roundels on posts along the length of Roundstone Lane to help with speeding and floor markings on speed bumps. | WSCC Enquiry | All issues discussed with WSCC Officer. Nursery Road - Clerk thas logged road marking issues on portal again and mention that WSCC Officer has visited site and to liaise with him. Update: Nursery Road – Road Markings - 3285669: I have inspected site and noted that these roads meet our investigatory levels for intervention. With this said, subject to future funding Nursery Road, Rowan Way and Bramley Way will be added to a future programme of refurbishment road marking works. Enquiry 3285669 - work needed will be completed once funds have been allocated. Bramley Way - As per the above. Roundstone Lane - As per above (part of same equiry) stating repeaters needed for 20mph signs. Update - Lack of 20mph signage – Roundstone Lane - 3285669: I have done some further digging into this section of road and I missed on site that this forms part of the 20mph Zone! The Department of Transport Traffic Signs Manual Chapter 3 (Section 8.7.1) specifies within a ‘zone’, speed limit repeater signage isn’t required, so long as there is a sufficient traffic calming feature at regular 100m intervals. There are many types of traffic calming features that can be used within a zone, including speed humps, road marking roundels, pedestrian refuge, junctions or bends in the road. Within nearby roads such as Nursery Road/Bramley Way, the priority/give way systems are essentially traffic calming features in themselves and unless there is evident need or fundamental change for additional signage at this location, extra 20mph repeater signage would not currently be a high priority at this time. | 12/02/2025 | KH |
| Road Signs | High Street into village | Fast traffic – suggestion slow sign on the bend at the top of the hill? A report has been submitted for the yellow lines to be repainted, 20mph floor markings to be repainted, as well as the addition of a SLOW floor marking as you travel from the top of the hill, towards the village square. | WSCC Enquiry | WSCC have previously not agreed to any of the suggestions made. Any signage advising vehicles that the road is unsuitable for HGVs could inadvertently cause a safety issue by alerting drivers too late as they approach the junction. This junction is sharp and manoeuvres could prove difficult, and telling vehicles in advance of the turning would be the most practicable solution. With this said, our stance regarding Unsuitable for HGV signs is that these are not currently a high priority. WSCC has adopted an evidenced based approach for these signs, and with the caveat that access is required to Arundel Road (a C-classification road with genuine business access), there may be no alternative route that is suitable for HGVs to use to enter Angmering. A280 - now the roundabout is being constructed - a sign may possible be added to say "Angmering Village Only" and "Not suitable for HGV's". Need to wait for final sign off of roundabout first.
