The Chair then reported on the following additional items:

Planning & Infrastructure Committee - Since the last committee meeting, this has been a very busy three weeks, especially this week with the Appeal Inquiry, there is a lot of information being sent to you which I hope you will find time to read and comment on, and I quickly add there is no rush. I also add that as we get closer to the acceptance of the Planning & Infrastructure Bill, still going through the Lords and Parliament, and Devolution there will be information about the changes in the planning system and the way in which we view planning applications. For the moment all remains as is.

Planning Councillor Training Manual – as a result of the experience gained at the recent appeal and the involvement of APC and the PFWBR Group under Rule 6 known as "The Angmering Alliance", the manual will be updated to include the procedures and conduct at such an appeal or any appeal. This is to ensure that in the event of it ever happening again Councillors and Residents will know what to do and be able to participate with confidence.

The Chair advised councillors that if they are booked to attend external training, they must let the Clerk know as quickly as possible if they cannot attend, as confirmed sessions not attended may incur costs.

The Consultation ends 14th November 2025 which can be accessed through the SDNP website.

15 PI25/156 APPEALS

Sought by an applicant as a result of an application refusal by the Local Planning Authority.

1) <u>Swallows Gate Vehicle Access, Dappers Lane.</u> - PINS ref: APP/C3810/C/25/3364403

We have been advised that from the 29th May 2025, the issue of an Enforcement Notice (ENF/6/20) is being appealed. We currently await further information on this appeal regarding the non-compliance with Condition 10 of A/142/16/OUT as varied by A/91/18/PL and detailed by A/111/23/DOC of 27th June 2023. Closure date for comments is 31st July 2025. This appeal is an Enforcement Notice Appeal, and the procedure is by way of Written representations. The decision on this could take 73 weeks which may not happen until the end of October 2026; however, as previously said, the developer has until April 2026 to fully comply with the condition.

The required footpath runs from the entrance into Swallows Gate, south along the western side of Dappers Lane to Merryfield Crescent. Councillors were asked to let the office know if any construction work on this footpath on Dappers Lane begins prior to next April.

2) Land West of Bewley Road. - PINS. ref: APP/C3810/W/25/3369419

Gleeson Land appealed against the refusal by ADC for the development of 190 residential dwellings and a community building together with the provision of

open space, landscaping and associated infrastructure. Application A/154/24/OUT refers.

The Inquiry finished today (4th November) so we now await the result which is expected at the beginning of 2026. The Flooding/Hydrology aspect of the Inquiry lasted for a day and a half. The planning aspects were conducted as a roundtable discussion between the Inspector, Barristers and legal planning witnesses. On Friday afternoon (31st October), the Inspector made another site visit which included the three legal teams, some members of the Rule 6 team and members of the public. The Chair added that prior to the Inquiry and during the Inquiry site visits were made by the Inspector and members of the legal teams. Although this last visit was made during half term the previous visits were made during school term time so all could see the problems relating to Arundel Road.

As Chair of APC P&I Committee, and as this is the first appeal of this magnitude that Angmering has been involved in, the Chair thanked everyone that was either involved in or contributed to it, for their dedication and hard work over very many months of working towards a dismissal by the Inspector. We now await the result due in January 2026.

16 PI25/157 CORRESPONDENCE

Correspondence continues between the Clerk and the Dappers Lane Group in response to the conversation at Full Council on Monday 13 October 2025. This item is added to the Highways Action List at agenda Item 17.

17 PI25/158 HIGHWAYS MATTERS

Highways Action List

The list was sent out with the supporting papers and uploaded to the APC website prior to tonight's meeting. The Chair talked through all items that had been updated.

Traffic Regulation Orders A280 – Speeding etc

Information has been received of the amount of accidents on the A280 and the excessive speed together with the use of the road by youngsters for time trailing, both of which are illegal. The County Councillor for Angmering Cllr Deborah Urquhart is in support of the legal speed being reduced to 50mph which will align with that of the A259, and a TRO has therefore been raised. Parish Council agreement will be discussed at the next Full Council meeting on 10th November 2025. This has now been added to the Highways Action List

Other Highways Matters affecting Angmering

a) Update on Water Lane Sewer work

An update on the continuing work has been received from Southern Water/Clancy, that as the village square is now open to traffic the final phase of improvement work will be continuing along Water Lane from the Lamb Inn with 15 excavations, therefore the entrance into and exit from the Square along Water Lane remains closed. Residents along Water Lane will still be able to access and egress their properties at all times. Parking along the residential side of Water Lane to Weavers Hill will not be permitted.

b) <u>Update on Traffic Lights/crossing replacement on the A259</u>

The work is now complete with the safe crossing and lights now fully operational. Any comments should be addressed to WSCC Highways. As there were no comments, this item is now closed.

c) Safety Concerns A259/A280 Roundabout

A resident has raised concerns over the design and safety of the roundabout and junctions off the roundabout near the Manor Place development. These concerns have been expressed to APC and WSCC Cllr Urquhart who has stated that WSCC Highways are aware of the situation and that there is still work to be done before the final safety audit is carried out and published. Be advised that this item will be added to APC's Highways Action List above. The correspondence has been sent to Councillors - are there any comments or questions.

d) <u>Dappers Lane</u>

The Save Dappers Lane Group and APC have been advised that there will be no further adjustments to the signage along Dappers Lane until after a 12-month period when the new signage has bedded in and any problems will have been highlighted. These can then be investigated and dealt with. Councillors and users are requested to report any problems to WSCC Highways and to The Parish Clerk.

There are many types of traffic calming features that can be used within a zone, including speed humps, road marking roundels, pedestrian refuge, junctions or bends in the road. Within nearby roads such as Nursery Road/Bramley Way, the priority/give way systems are essentially traffic calming features in themselves and unless there is evident need or fundamental change for additional signage at this location, extra 20mph repeater signage would not currently be a high priority at this time.	12/02/2025	КН
