#### Agenda Item 11, RED LION HOUSE NOTICEBOARD

Angmering Parish Office has received the following request from The Angmering Heritage Trust regarding the noticeboard located on the outside wall off the Office:

Following our telephone conversation yesterday I said I would email you about the Red Lion House notice board.

As I explained, this notice board was made by Fred Rowley for the Angmering Society to be used for village notices. The Angmering Heritage Trust was set up to administer the assets of the Society when it was disbanded and Jane Rowley, who was one of our Trustees, arranged about 3 years ago for the noticeboard to be refurbished and a new lock put on.

In our minutes from June 2016 it states that "Jane will ask the administrator in the Angmering Parish Council office for a letter confirming that APC will be willing to take over responsibility for the noticeboard when the time comes for AHT to be wound up".

I'm not sure whether we ever received such a letter but in any case the Trustees feel that since neither Fred nor Jane Rowley are around to take a personal interest in the noticeboard's maintenance and upkeep, perhaps the PC would take over the responsibility for the noticeboard now.

I look forward to hearing from you once the PC has considered this proposal.

**Things to consider:** The Board is in good condition and as far as we can see does not have any maintenance issues at present.

As the colour is not green, we could consider painting the board to match the other noticeboards within the village, we estimate the cost to be  $\underline{£36.00}$  (this is something that Roy can do).

We have approached the signage company that made and installed our new noticeboards to obtain a cost for adding an Angmering Parish Council sign to the top of the board, again to match as far as possible the other noticeboards, the cost for this will be approx. £453.00. We have approached the local sign producer, but they were unable to help.

Decision Needed: To decide if Angmering Parish Council should take on responsibility of the board.

Engineer Notes :-

Fan on psu making loud noise.

Cleaned fan and Inside box. Fan stopped making noise but shortly after started making the noise again. I would suggest that the psu fan needs replacing. I've taken photos. DVR is an inspire 8 channel.

Camera 3 Intermittent. Camera was OK when I was there. Checked connections and all seemed OK. I cannot see any issue as it is working.

Please quote for new DVR and a separate quote for psu fan to show what's more cost effective.
