Community-Led Neighbourhood Plan – More Volunteers Needed

The Government's Localism Bill is nearing completion of its progress through Parliament. Once it becomes law it will give the local community rights to shape future development and the use of land within our parish through the production and endorsement by the local electorate, through a local referendum, of a Neighbourhood Plan. Once endorsed, all planning authorities will be required to take due regard of the Neighbourhood Plan in considering any future planning proposals that affect our parish. Although we've started please join us – we need you!!



Our intention is to work actively and co-operatively with the community to produce a comprehensive Community-Led Plan that will address not only those aspects of future development that will form the content of the Neighbourhood Plan, but also will cover all material aspects of future design, transport and other infrastructure, service and amenity provision, business and employment opportunities and quality of life over many years to come. Following indications of interest from over 50 local participating residents, those participants

and all parish councillors have now each been assigned to 7 working groups covering:

- Housing Needs & Development
- Local Business & employment Opportunities
- · Local Roads, Transport & Parking
- Local Sports & Leisure Facilities
- & Public Amenities
- Education
- Health & Medical Facilities; and
- Staying & Feeling Safe (Crime & Road Safety)

The Steering Group for the project will comprise the 7 working group Chairs and 5 parish councilors.

The aim is to produce proposals and options for consideration by the local community via public consultation around the end of this year. The feedback from that consultation will then determine the content of a draft Community-Led Neighbourhood Plan which will be shared and discussed with Arun District Council, West Sussex County Council and the South Downs National Parks Authority and submitted for independent examination in line with the requirements of the Localism Bill.

Please join us at St **Margaret's Church Hall on** Thursday 3rd November, 2011 at 7:00pm for a public meeting to discuss the Travellers Issues in the Village. 

Housing Needs Survey

Yes, the Neighbourhood Plan team want you to do another survey. The big question is why this is necessary, to which the answer is that the first survey indicated how strongly the Community felt about housing matters and in order to formulate the policies for the future, we need more information.

IT IS JUST AS IMPORTANT TO FILL THIS FORM IN AND RETURN IT AS IT WAS FOR THE LAST ONE, and the response to that was brilliant.

The application from Barratt/David Wilson Homes has shown how important the Neighbourhood Plan would be for the future. We need to know what the people of Angmering NEED for the future of housing in the village and not what others tell us we need. The information would provide us with ammunition for defending the village from inappropriate development which will eventually end up importing problems from other areas of Arun. Hence, the request for all to complete the first page of the questionnaire telling us your views about housing in the future for the village. If you particularly need some form of truly 'affordable' housing (not just rented) for the future, then please complete Part 2 and send it back as well. All personal information will be kept strictly confidential and will only be used for the purpose of providing evidence for our future policies.

An example of the problems that we are trying to avoid is that, within a development such as the Barratt development proposals, 45 homes would be built as 'Social Rented Houses', which will eventually be allocated to a Housing Association and used to fulfil Arun District Council's housing list requirements. We believe that this will not provide housing for those that need it in Angmering, but we need the evidence to prove that.

The first survey results

The overall return for the first survey was excellent with 1,367 forms being returned, representing over 40% of those distributed, so many thanks to all, including those that circulated the forms and especially all of you that sent yours back. It shows how much we care about the future of the village.

A summary of the key findings from the survey is on our website <u>www.angmeringparishcouncil.gov.uk</u> with some of the main ones being:-

- 33% of those that responded were over 65 years of age and a similar percentage had lived in the village for 20 years or more.
- Two-thirds of you agreed that the Parish Council should see through the Neighbourhood Plan project and a similar fraction agreed that future development should fulfil the needs of the people of the parish only.
- More than 80% of you strongly believed that development should not result in the loss of amenities with even more saying that Greenfield sites should be protected.
- Large majorities were in favour of having smaller developments (up to 10 units at a time) with the preference being

for an overall total of up to 100 units over the time covered by the Plan (2028). In addition, more than 80% did not want an extension to the built-up area boundary on which to put that development.

- Affordable housing was strongly preferred to meet local needs only by two-thirds of you, with a similar proportion favouring this housing being best controlled by the local community.
- ☐ The remainder of the survey dealt with matters relating to the businesses, employment, highways, health amenities, safety and education. In virtually all cases you gave a strong steer to those undertaking the work on the Plan, so, once again, thank you for taking the time.

The next stage is the Housing Needs Survey, which is essential for that aspect of the plan, so bear with us.

Neighbourhood Plan progress

The work on the Plan has continued, but waiting for the survey analysis has slowed progress over the summer. The next task is to take your answers and converting them into robust local policies that will stand up to scrutiny by both Arun District Council and the Planning Inspectorate before being put to you, the electorate, in the form of a referendum for acceptance as being the Planning Law for Angmering. The current hoped-for date for this referendum is next May, but the draft Plan will be sent out to you to consider well before this.



Planning Application by David Wilson Homes

The long awaited application has now been made and the Parish Council will have held a meeting dedicated to its response to this. The proposal is for a total of 150 new homes, including 45 identified as 'Social Rented', on land to the east of Roundstone Lane. The Parish Council will decide on its view of the application once the Papers have been analysed and considered.



Parish Emergency Committee

As a consequence of the flooding on 11th June 2012, the two members of the Parish Council, Councillors Susan Francis and Sylvia Verrinder and the Parish Clerk, Rob Martin, held a de-brief meeting afterwards to discuss:-

- what had happened
- how it had happened
- who was affected by the flooding
- where the additional flooding areas were
- the action taken, and
- what to do in the future.

It was resolved that the Parish Emergency Plan, started over a year ago, should be finalised and a Parish Emergency Team consisting of Councillors and residents be set up to finalise the overall plan. This plan will be activated as and when an emergency happens either with or without warning. In the event that none of the Emergency Services can get to the Parish, then the parish must be able to sustain itself. This is where all residents will be expected to play their part in saving lives and the Parish.

Eventually it is intended to hold public meetings explaining the plan, with contributions from the Emergency Services and the District and County Emergency Teams, and Resilience Teams, together with companies demonstrating products that residents can use to safeguard their homes, especially in areas of extreme flooding. It is also intended to hold training sessions with mock situations to practise the emergency plan.

Chairman's Report

2012 was a year of high's and low's and I have no doubt that 2013 will bring some difficult times for our Parish particularly regarding the potential developers who are currently bombarding our Parish with planning applications.

During 2012 we had the first Angmering Fete which although delayed by the weather proved a great success in September and was a testament to the hard work of all those on the organising committee. We also entered the Village in Bloom and achieved success demonstrated by the abundance of beautiful plants and flowers which made our Village look very pretty.

The floods of June and July bought chaos to the village and severe damage to properties especially in Water Lane. The Parish Council Emergency Plan Committee which was in the course of preparation when the floods came is now fully functioning and extensive work with the Environment Agency and West Sussex CC is on-going to alleviate a number of long standing flood issues in the Parish.

We continue to enjoy a high level of support from our MP Nick Herbert and his commitment to support Angmering and in particular our Neighbourhood Plan greatly assists us.

Community Land Trusts provide for the people of the Parish (Not the Parish Council) to take ownership of assets within the Parish and to manage them for the benefit of all Parishioners. An open day was held on the 27th April to publicise the proposals.

The Parish Neighbourhood Plan has been progressing well, regretfully the legal framework for completing this is quite slow with over 20 weeks of consultation needed during 2013 however we are hopeful you will all be able to review this document and vote in the referendum around December 2013.

Your Parish Council will continue to provide improvements and new facilities during this year and our grateful thanks are due to the people of the Parish who help and support us in our endeavours.

ANGMERING NEIGHBOURHOOD DEVELOPMENT PLAN DROP-IN SESSION

There will be a Neighbourhood Plan Drop-In Session for you all to come and see what is being proposed. The session will be on Saturday 8th June 2013 between 9am and 1pm and will be held in the Kings Suite at the Village Hall.

The plan has been developed to reach a pre-submission stage and has a number of policies in it to influence the future of the village. There will be a chance to look at the proposed plan and to talk about what it all means with those that have prepared it. A copy of the current version of the plan is available on the Parish Council website www.angmeringparishcouncil.gov.uk and hard copies can be obtained on the day.

The development of the plan is reaching an advanced stage and the aim is to have it ready for a referendum by the end on 2013, with a number of official consultation stages to go through before then.



It is really important that as many of you come along to give your views as you can. This is for everyone, whether you are employed or unemployed, retired, in education, or a homemaker. You may own your own home or live in rented accommodation, there is absolutely no criteria except that you live in the Parish of Angmering. Your views are important. Please come along and give a little time to contribute to the production of the plan. Once it becomes official the plan will form a part of the planning law for Angmering and this will be in place for the next 15 years. We look forward to seeing you on 8th June.

Angmering Community Land Trust open day, 27 April 2013

The Angmering Community Land Trust (ACLT) Open Day on Saturday 27 April 2013 attracted around 40 attendees with people interested in what the project was trying to achieve. The day appeared to be successful with 19 people putting their names forward for varying degrees of involvement in the development of the Trust.

The current position is that ACLT has been registered as an Emerging Land Trust on the National Network and will be represented at the National conference in Birmingham in June 2013. The next stage is for the legal framework to be defined, which current thoughts believe will be in the form of a Company Limited by Guarantee, but advice on this will be sought from experts in the field. The formation of the appropriate structure will be the next job, along with setting up bank accounts and applying for initial grant funding.

Angmering housing needs survey

The Housing Needs Survey was conducted in October 2012. 871 of the 3,500 households in the village sent their forms back, equivalent to more than 24%. The complete summary of the answers is available of the parish council website <u>www.angmering-pc.</u> <u>gov.uk</u> and a few comments on the results are as follows.

The analysis of the data is fairly extensive and includes some national statistics from the 2001 census for comparative purposes. The first section deals with the reasons why and the way the survey was conducted.

Section 2 deals with the Parish of Angmering and analyses the information in the 2001 census, comparing the Parish with the Arun District position and also the national picture.

Section 3 looks at the affordability of houses in Angmering by comparing the lowest property prices against the levels of income necessary to be able to either rent or buy specific types of property.

Sections 4, 5 & 6 deal with the expression of views on affordable housing and the identified needs for this type of accommodation, whilst Sections 7 & 8 deal with Market Housing need.

The broad conclusions drawn from the survey were that whilst there was a small proportion of affordable housing in the parish, there was only a small need for such accommodation, with only 25 households expressing a wish for it. This is much smaller than would normally be expected for a parish of this size. This did not detract, however, from the fact that these people had a need that should be satisfied with the majority needing it within the next 5 years.

As far as Market Housing was required, even fewer people identified a need than for affordable housing. This would indicate that there was very little need within the parish for new housing development.

The results of this survey have helped to inform the Neighbourhood Planning team and will feed into the work of the newly formed Community Land Trust.
