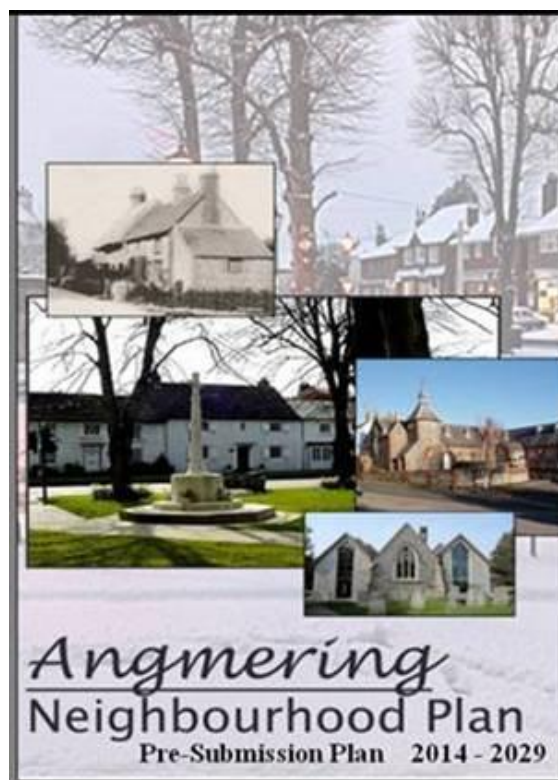

The Neighbourhood Plan should improve the economic, social and environmental well-being of Angmering Parish.

Policies and projects include:

- Encourage development that supports the needs of the community - affordable homes for residents of Angmering.
- Provide sufficient places in village schools: improved youth and leisure facilities: open spaces and play areas.
- Support opportunities for small businesses.
- Protect our current shops and businesses.
- Manage the impact of traffic and support sustainable transport.
- Protect our green spaces.
- Have a say in all future development proposals.
- Allocate areas for more allotments.

## WHAT HAPPENS NEXT?

Following the 6 week pre-submission period the Steering group will look at all the comments made and will amend the Plan accordingly.

It will then go to the examiners at Arun for a further 6 week check.

Subject to this being satisfactory and the group making any amendments to the Plan recommended by the examiner, it will then go to a full referendum in December.

Every household in the Parish will receive a copy of this final plan at this point.

Look out for posters in the village advertising drop-in sessions and presentations during the 6-week consultation period.
