It might be helpful to define a few of the terms in the survey.

**Affordable Housing** – this covers a number of different types of housing provision including low-cost rented (sometimes called 'social'), low-cost purchase, equity-share purchase and various 'keyworker' arrangements.



**Neighbourhood Development Plan** – made legal under the Localism Act 2011, this enables Communities to put together a plan that will become planning law in their areas, providing it fulfills a number of criteria and is approved by local referendum.

**Infrastructure** – this includes not just the usual concerns about highways, but also whether sewers are up to the job or whether water supplies will be compromised by development.




